***agree upon and stipulate the following:***

**ART. 1  
OBJECT OF THE CONTRACT**

This contract relates to the collaboration relationship, in the form of technical sponsorship, between the Embassy of Italy in Wellington and the Company ....., which is given the title of Sponsor of the events linked to the celebration of the Italian Republic Day on the 5<sup>th</sup> of June.

**ART. 2  
BINDING CLAUSES**

All the contents of the above-mentioned public notice published on the website of the Embassy of Italy in Wellington on the 13<sup>th</sup> of May 2025 concerning the search of sponsors constitute binding clauses of this contract.

**ART. 3  
OBLIGATIONS OF THE SPONSOR**

The Sponsor undertakes to provide the following:

in favor of the Embassy of Italy in Wellington within 10 days from the date of signing this contract and no later than the 5<sup>th</sup> of June 2025;

**ART. 4  
OBLIGATIONS OF THE SPONSEE**

The Sponsee undertakes to promote the brand, image and activities of the Sponsor in the context of the activities planned for each event, in accordance with the procedures indicated in the aforementioned public notice concerning the search of sponsors.

**ART. 5  
DURATION OF THE CONTRACT**

This contract is effective from the date of the signing of both parties until the respective commitments have been executed.

**ART. 6  
TERMINATION OF THE CONTRACT**

This contract will be terminated:

- a) if the Sponsor is in default in relation to the respective contractual obligations;
- b) if conflicts of interest arise between the activity of the Embassy of Italy in Wellington and that of the Sponsor, without prejudice to:
  - 1. the attempt to resolve the conflict to safeguard the public interest;
  - 2. the rights accrued by the parties at the time of termination of the contract;
- c) if acts and/or facts are put in place, even indirectly, damaging the image, activities and the right of confidentiality of each party.

**ART. 7  
WITHDRAWAL FROM THE CONTRACT**

The Sponsee has the right to withdraw from this contract at any time for reasons of public interest and /or for reasons of foreign policy, upon simple request, without conditions or limitations of any kind, free of charge and without prejudice to the right to the return of advances of price paid previously and exceeding the consideration for services already rendered and delivered.

**ART. 8  
TREATMENT OF PERSONAL DATA**

Pursuant to and for the purposes of art. 13 of Regulation (EU) 2016/679, the personal data provided by the Sponsor mandatory for the purposes related to the stipulation and management of this contract, will be processed by the Embassy of Italy in Wellington, in compliance with the provisions contained in the same legislation.

**ART.9.  
DISPUTES**

Any disputes relating to this contract or in any case also indirectly attributable to it, will be settled amicably. Otherwise, the competent court is that of Rome.

**ART. 10  
REFERENCE**

For any matter not provided for in this contract, reference is made to the laws, regulations and regulatory provisions in force.
